AFFIDAVIT OF HEIRSHIP

PERSONALLY APPEARED BEFORE ME, the undersigned authority in and for said county and state, the within named, General George Young Mitchell and Bernice J. Watkins who after being duly sworn state upon their respective oaths as follows:

1. That they knew JAMES RIST prior to his death, and that said JAMES RIST died in the early 1900s.
2. That they knew ELMA RIST prior to her death, and that said ELMA RIST died in the early 1900s.
3. That to their own personal knowledge, JAMES RIST AND ELMA RIST had seven children, who are Emperor Rist, Sr. (deceased), Governor Rist (deceased), Jeffery Rist (deceased), Claudia Young, Katie B. Young, Jannie Lee Rist, and Emily Thompson (deceased).
4. That Emperor Rist, Sr. died on or about May, 1999. Emperor Rist, Sr. was survived by his wife, Allie Mae Rist. That Emperor Rist, Sr. had one child, Emperor Rist, Jr., who predeceased him on or about September 5, 1981. That Emperor Rist, Jr. was divorced at the time of his death. That Emperor Rist, Jr. had one child, who is Timothy Rist. That to their own personal knowledge the sole and only heirs-at-law of Emperor Rist, Sr. are Allie Mae Rist and Timothy Rist.
5. That Governor Rist died in 1958. At the time of his death, Governor Rist was married to Dora Rist. That to their own personal knowledge, the sole and only heirs-at-law of Governor Rist are his wife, Dora Rist, and four (4) children, who are Charles Rist, James Rist, Ethel Rist, and Mary Johnson.
6. That to their own personal knowledge, Jeffery Rist died in 1935, and that at the time of his death, he was 15 years of age and had no children.
7. That Emily Rist Thompson died on or about March 2, 2002. At the time of her

death, Emily Rist Thompson was married to A. B. Thompson, who died on or about July 14, 1985. That to their own personal knowledge, the sole and only heirs-at-law of Emily Rist Thompson are her two (2) children, who are Wilbert Thompson and A. B. Thompson, Jr.

8. That to their own personal knowledge all of the said heirs are above the age of twenty-one years and subject to no legal disabilities and all of the debts against said estate have been paid.


