WARRANTY DEED

FOR AND IN CONSIDERATION of the sum of \$10.00, cash in hand paid, and other good and valuable considerations, the sufficiency and receipt of which are hereby acknowledged, we, EVA REDFIELD, VERA CHAFFEE, I.W. JENNINGS, PEGGY J. KENNEDY, HAZEL MAGEE FEARENCE, JOANN RODGERS, ORA LEE DILLON SMITH, THELMA DILLON BOWDEN, MARY DEAN BRUMFIELD HAYES, VIVIAN BRUMFIELD FORD, AND BOBBIE JEAN BRUMFIELD TUCKER, do hereby convey and warrant unto MICHAEL RAY NOLAN all of our interest in and to the following described real property situated in Pike County, Mississippi, to-wit:
